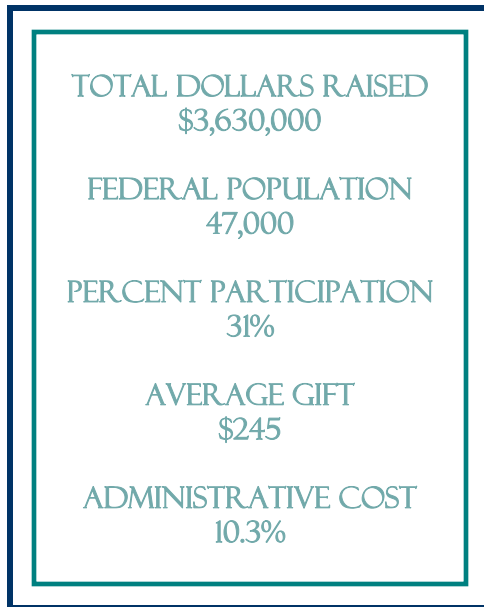
## 2009-2010 ANNUAL REPORT
